DESCRIPTION**

DEPUTY TREASURER

Position Summary: Provides front office support and completes related accounting tasks, customer service and administrative support activities related to finance and treasury functions.

Reports to: Finance Director/Treasurer

Supervises: No supervisory responsibility

ESSENTIAL JOB FUNCTIONS:

An employee in this position is required to perform the following essential functions with or without reasonable accommodation. These examples are not an exhaustive list of the duties, which the employee may be expected to perform.

1. Answers phones and directs calls to appropriate department and personnel. Assists customers by phone, providing information according to established procedure.
2. Assists customers in person at the counter. Directs to the appropriate department and personnel and provides information according to established procedure.
3. Receives payments in person and by mail, posts to appropriate accounts, issues receipts and records daily cash receipts.
4. Posts daily cash receipts to the general ledger.
5. Balances cash register and makes deposits.
6. Processes payroll. Reviews and enters timesheets, allocates to proper departments and runs reports to ensure accuracy. Prints payroll checks, processes direct deposits and withholdings and maintains accrued time off records.
7. Processes accounts payable. Reviews coded bills, organizes and enters information and prints checks. Runs related reports to ensure accuracy and responds to questions from vendors.
8. Prepares correspondence related to zoning enforcement and provides general clerical and administrative support to the Finance Director / Treasurer and others as assigned
9. Assists customers with community building rental. Provides appropriate paperwork and collects deposits and fees.

11. Assists with monthly public works equipment rental report as assigned.
Updates rental amounts and produces new time sheets as directed.
12. Performs other duties as assigned.

MINIMUM QUALIFICATIONS AND REQUIRED KNOWLEDGE, SKILLS, ABILITIES:

The requirements listed below are representative of the minimum qualifications, knowledge, skills, and abilities required to successfully perform the essential functions of the position.

Requirements include the following:

- Associate's Degree or the equivalent in accounting, business or a related field.
- Three or more years of experience in accounting or a related field, preferably in a municipal setting.
- Knowledge of the principles and practices of accounting and general business administration.
- Knowledge of City services, organizational structure and general operations to effectively direct and assist the public.
- Skill in maintaining computerized accounting records and in utilizing related financial systems and software.
- Ability to enter data and complete word processing with speed and accuracy.
- Ability to maintain attention to detail and work within deadlines.
- Ability to establish and maintain effective working relationships and use good judgment, initiative and resourcefulness when dealing with the public and co-workers.

Physical Requirements and Work Environment:

The physical demands and work environment described here are representative of those an employee encounters while performing the essential functions of the job. Reasonable accommodations may be made to enable individuals with disabilities to perform the job.

An employee in this position spends the majority of their time in an office setting with a controlled climate where they sit and work on a computer for extended periods of time, communicate by telephone or in person, and move around the office to assist customers and complete other administrative duties.
